**NAME**

The name of the corporation is MEDICAL SAFETY SYSTEMS, INC.

**ARTICLE II**  
**DURATION**

This Corporation shall have a perpetual existence.

**ARTICLE III**  
**PURPOSE**

1. This Corporation is organized for the purpose of transacting any and all lawful business.

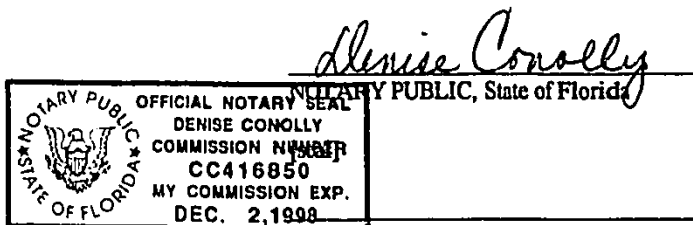


