ARTICLE I

The name of this corporation shall be ASHA MUNSHI, M.D., P.A., and its principal office shall be 4332 Bent Tree Boulevard, Sarasota, Florida 34241.

ARTICLE II

This corporation shall have perpetual existence, which shall commence at the time of the filing of these Articles of Incorporation with the Department of State.

ARTICLE III

The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes. The corporation shall also have all other powers provided in the statutes of the State of Florida. The specific nature of business of this corporation will be physician services.

ARTICLE IV

The corporation is authorized to issue 500 shares of common stock of a par value of \$1.00 per share.

ARTICLE V

The number of Directors constituting the initial Board of Directors shall be one (1). The number of Directors may be increased or decreased from time to time by the By-Laws but shall never be less than one (1).

(b) The Board of Directors of the corporation is hereby authorized and empowered, from time to time, at its discretion, to:

(i) make and amend By-Laws of the corporation;

(ii) establish such reserves as the Board may deem necessary and in the best interests of the corporation and to set such funds aside for the purpose of the reserve.
