ARTICLES OF INCORPORATION OF

PEDIATRICS PLUS OF CENTRAL FLORIDA, P.A.

The undersigned hereby makes, subscribes, acknowledges and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a professional service corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I Name

The name of this corporation shall be:

PEDIATRICS PLUS OF CENTRAL FLORIDA, P.A.

ARTICLE II Existence of Corporation

This corporation shall have perpetual existence.

ARTICLE III Business, Objects or Purposes

The general nature of the business to be transacted by this corporation or the objects or purposes of the corporation shall be as follows:

- (a) To engage solely and specifically in the business of carrying on the practice of pediatric medicine.
- (b) To invest in real estate, mortgages, stocks, bonds or any other type of investments.
- (c) To own real and personal property necessary for the rendering of the above professional services.
- (d) In general, to have and exercise all powers conferred by the laws of Florida upon professional service corporations, and to do any and all things hereinabove set forth to the same extent as a natural person might or could do.

ARTICLE IV Capital Stock

- (a) The total number of shares of capital stock authorized to be issued by the corporation shall be 7,500 shares having a par value of \$1.00 per share. Each of the said shares of stock shall entitle the holder thereof to one (I) vote at any meeting of the stockholders. - (b) In the election of directors of this corporation there shall be no cumulative voting of the stock entitled to vote at such election.
