

The undersigned, as subscribers to these articles of incorporation, as natural persons competent to contract, hereby present these articles of incorporation for the formation of a corporation under the provision of Florida Statutes

**Article I - Name**

The name of this corporation is Southern Plus Enterprises, Inc

**Article II - Purpose**

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the state of Florida and the laws of the United States.




