

ARTICLES OF INCORPORATION
OF
KRYSTAL AUTO GLASS, INC.

ARTICLE I

The name of this corporation is KRYSTAL AUTO GLASS, INC.

ARTICLE II

The corporation is to exist perpetually, commencing on the date of filing of these Articles.

ARTICLE III

This corporation is organized for the purpose of installation and repair of automobile glass and any other lawful business for which corporations may be incorporated under the Florida Business Corporations Act.

ARTICLE IV

This corporation is authorized to issue Two Thousand (2,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

ARTICLE V
