ARTICLE VI-BOARD OF DIRECTORS





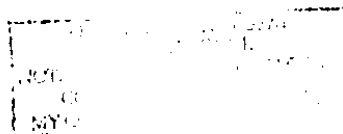
