ARTICLE I- CORPORATE NAME

The name of this corporation is: WATER WORLD AQUARIUMS OF SOUTH FLORIDA, INC.

ARTICLE II- NATURE OF BUSINESS AND POWERS.

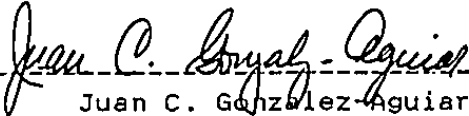
