ARTICLES OF INCORPORATION  
of  
ASSOCIATION OF PROFESSIONAL TRAINERS, INCORPORATED

A Florida For-Profit Corporation

The undersigned, incorporators at 119 Monahan Drive, Fort Walton Beach, Florida 32548, Okaloosa County, being at least eighteen years of age, do hereby form a Corporation under Chapter 607 of the general laws of the State of Florida.

ARTICLE ONE

NAME

The name of the corporation is Association of Professional Trainers, Incorporated.

ARTICLE TWO

PURPOSES

The purposes for which the corporation is formed are as follows:

To do such acts and carry on such business as may be permitted by Chapter 607, Florida Statutes, subject to the limitations thereof.

ARTICLE THREE

PRINCIPAL OFFICE AND RESIDENT AGENT

Unless otherwise required by law, no Director of this corporation shall have personal liability for any act or omission taken in good faith while exercising any such duties, rights, powers, immunities and privileges.

##### CAPITAL STOCK

The number of shares of stock which the corporation is authorized to have outstanding is twenty (20), which shall be divided into twenty (20) shares of Common stock, at a par value of five dollars (\$5.00) each. Each share shall be entitled to one (1) vote in matters described in the corporate Bylaws. No stock in this corporation may be sold gifted or otherwise transferred except to the corporation. Each such stock ownership change shall occur only upon approval by the Board of Directors.

The amount of stated capital with which the corporation shall begin business is one thousand dollars (\$1,000.00).
