The name of this Corporation is:

a majority vote of the shareholders of this Corporation.

The number of the Director(s) may be either increased or decreased from time to time by the by-laws of the Corporation, but shall never be less than One (1). The Corporation shall indemnify any and all Officers or Directors, or any former Officer or Director, to the full extent permitted by-law for all acts done on behalf of the Corporation.


ARTICLE XI



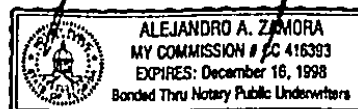
