ARTICLE I  
NAME

Section 1.1. The name of this corporation is ALLSTATE CARPET  
CLEANING AND RESTORATION, INC.

ARTICLE II  
DURATION AND COMMENCEMENT OF EXISTENCE

Section 2.1. This corporation shall commence on the date of  
filing of these Articles of Incorporation. This corporation shall  
have perpetual existence.
