ARTICLES OF INCORPORATION

OF

INSERVICE & CONSULTING ASSOCIATES, INC.

ARTICLE I - NAME

The name of this Corporation is: INSERVICE & CONSULTING ASSOCIATES, INC...

ARTICLE II - DURATION

This Corporatio shall have perpetual existence commencing upon filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This Corporation is organized for the following purposes:

To transact any and all lawful business and to have and to exercise all the powers now or hereafter conferred by the laws of the State of Florida upon corporations organized pursuant to the laws under which this Corporation is organized and any and all acts amendatory thereof and supplemental thereto.

No person may become a shareholder of this corporation unless they consent to this election and are not otherwise unqualified to so elect. This article shall be ineffective if one hundred (100%) percent of the shareholders affirmatively decline the § 1362(a) election.
