ARTICLES OF INCORPORATION
OF
STAR GOLD INTERNATIONAL CORPORATION

ARTICLE I - NAME
The name of this corporation is Star Gold International Corporation

ARTICLE II - DURATION
This corporation shall have perpetual existence.

ARTICLE III - PURPOSE
The general nature of the business to be transacted by this corporation shall be any and all activities permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV - CAPITAL STOCK
This corporation is authorized to issue 100 (One Hundred) shares of common stock with the par value of \$ 30,000.00 (thirty thousand dollars)

ARTICLE XIV - POWERS

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act

ARTICLE XV - DIRECTORS RESIDENCY AND COMPENSATION

Directors of this corporation may be or not residents of the State of Florida - USA

ARTICLE XVI - REMOVAL OF DIRECTORS

The shareholders of this corporation shall not be entitled to remove any director from office during this term

ARTICLE XVII - LIMITATION ON POWERS OF COMMITTEES

In addition to other limitations imposed by laws, no committee of directors of this corporation shall have or exercise the power of the Board of Directors to authorize any merger or dissolution.

ARTICLE XVIII - DIRECTOR QUORUM AND VOTING

All the directors shall constitute a quorum for a meeting of directors.

If a quorum is present the affirmative vote of all of the directors present, or, if a director or directors have abstained from voting, shall be the act of the Board of Directors.





ARTICLE XXI - INDEMNIFICATION


