Article I - Name

The name of this corporation is THE HEALTH RADIONETWORK GROUP, INC.

Article II - Duration

This corporation shall have perpetual duration commencing on the date of filing these Articles with the State of Florida.

Article III - Purpose

Article IV - Capital Stock
