ARTICLES OF INCORPORATION OF

LAKE PLACID CHEVRON, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, documentable act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the corporation is LAKE PLACID CHEVRON, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office is 2. U.S. 27 South, Lake Placid, Florida 33852.

ARTICLE III - DURATION

The duration of the corporation shall be perpetual.

ARTICLE IV - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V - CAPITAL STOCK

The maximum number of shares this Corporation is authorized to issue is 500 shares of Ten Dollar (\$10.00) par value which shall be "Common Shares". All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.
