

ARTICLES OF INCORPORATION OF UNCLE MIKE'S TREASURES, INC.

The undersigned for the purpose of forming a corporation under the Florida General Incorporation Act does hereby adopt the following articles of incorporation.

Article I: The name of the corporation is UNCLE MIKE'S TREASURES, INC.

Article Two: The duration of the corporation is perpetual.

Article III: The general purposes for which the corporation is organized are:

- A. To carry on the business of retail groceries and other merchandise.
- B. To transact any other lawful business for which corporations may be incorporated under the Florida Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors, be advantageously carried on in connection with or auxiliary to the foregoing business.
- C. To do other things as are incidental to the foregoing or necessary or desirable or auxiliary to the foregoing business.

Article IV: The aggregate number of shares which the corporation is authorized to issue is ONE THOUSAND SHARES. Such shares shall be of a single class and shall have a par value of One (\$1.00) Dollar per share. Said single class shall be COMMON STOCK.
