ARTICLES OF INCORPORATION  
OF  
SOUTHERN PRIDE CONSTRUCTION, INC.

The undersigned incorporator hereby executes and acknowledges these Articles of Incorporation for the purpose of forming a corporation under the Florida General Corporation Act.

ARTICLE I, NAME

The name of the corporation is: Southern Pride Construction, Inc.

ARTICLE II, DURATION

The duration of this corporation is perpetual.

ARTICLE III, PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV, CAPITAL STOCK

The aggregate number of shares of capital stock authorized to be issued by the corporation shall be 1,000 shares of common stock with a par value of \$1.00 per share.

ARTICLE V, PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock or treasury stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI, INITIAL REGISTERED OFFICE AND INITIAL  
REGISTERED AGENT

The street address of the initial <sup>Principal</sup> ~~registered~~ office of this corporation is 10342 Atlantic Circle, Suite #4, Jacksonville, Florida 32246, and the name and address its initial registered agent is Harold J. Potter, Jr., 1171 Lane Ave. So., #1102, Jacksonville, Florida 32205. This corporation shall have the right to change such registered office and such registered agent from time to time, as provided by law.

ARTICLE VII, INITIAL BOARD OF DIRECTORS

The shareholders may, by agreement, impose any reasonable restraint on transfer or alienation of the shares of stock of this corporation.


#### ARTICLE X, BY LAWS


