ARTICLES OF INCORPORATION OF

CAROLINA TRANSPORTATION, INC.

The undersigned, acting as incorporators of a corporation's pursuant to Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be CAROLINA TRANSPORTATION, INC.

ARTICLE II

The corporation shall exist perpetually and for an indefinite period, commencing on the 22nd day of November, 1996.
