

of common stock having a par value of \$1 per share.



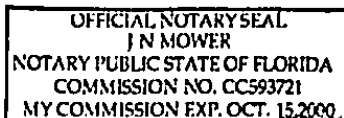
