ARTICLE I

NAME

The name of this corporation is MAALI BEEPERS, INC.

ARTICLE II

EFFECTIVE DATE

This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
