ARTICLES OF INCORPORATION OF CHE-CHENT CHAIRS, INC.

PREAMBLE

We, the undersigned Subscribers, natural persons, competent to contract, do hereby associate ourselves under the following Articles of Incorporation, and form a Corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of the Corporation shall be CHE-CHENT CHAIRS, INC.

ARTICLE II PRINCIPAL ADDRESS AND MAILING ADDRESS

The principal address of the Corporation is 21427 Town Lakes Drive, Apartment 2211, Boca Raton, Florida 33486, and the mailing address of the Corporation is 21427 Town Lakes Drive, Apartment 2211, Boca Raton, Florida 33486.

ARTICLE III PURPOSES

The purpose for which the Corporation is formed and the business and objects to be carried on and promoted by it are:
