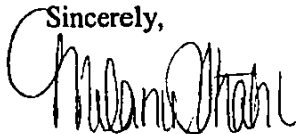

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a Corporation under the laws of the State of Florida.

**ARTICLE I - CORPORATE NAME**

**ARTICLE II - DURATION**

This Corporation shall exist perpetually unless dissolved according to Florida law.

**ARTICLE III - PURPOSE**

This Corporation is engaged for the purpose of engaging in the national and international sales of long distance services, and any other business or activity connected with this work.

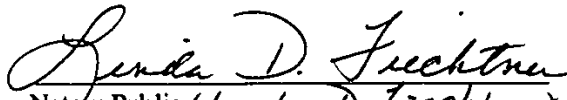
