DAVIS & SENTNER, P.A.


Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act,
the undersigned corporation adopts the following Articles Of Amendment to its Articles Of
Incorporation:

1. The original name of the corporation was KEVIN A. SENTNER, P.A., which
was changed to DAVIS & SENTNER, P.A. by Articles of Amendment effective
January 1, 2001. These Articles Of Amendment change the name of the
corporation back to KEVIN A. SENTNER, P.A.
2. The text of the amendment is as follows:

3. The amendment was adopted by the corporation's sole shareholder and director
