ARTICLES OF INCORPORATION  
NATIONAL HEALTH STYLES, INC.

THE UNDERSIGNED subscriber to these articles of incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

I

The name of this corporation shall be NATIONAL HEALTH STYLES, INC. and the principal place of business shall be 5740 HOLLYWOOD BLVD. #600, HOLLYWOOD, FLORIDA 33021.

II

This corporation may engage in or transact any and all lawful business and/or activities permitted under the laws of the State of Florida, of the United States, and of any other state, country, territory or nation, and shall have all of the powers granted to a corporation under the State of Florida, of the United States, and of any other state, country, territory or nation.

III

This corporation is authorized to issue 1000 shares of common stock of a par value of 1 dollar a share.

IV

The initial address of this corporation shall be 5740 HOLLYWOOD BLVD. #600, HOLLYWOOD, FLORIDA 33021 with the privilege of having its offices and branch offices at other places within or without the State of Florida. The power to adopt, alter, amend or repeal by-laws shall be vested in the board of directors.




