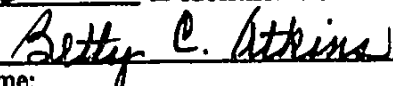

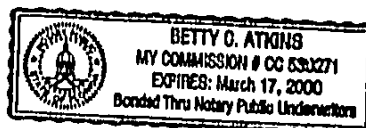

ARTICLES OF INCORPORATION  
OF

The undersigned, acting as the incorporator of GULF-TO-BAY ANESTHESIOLOGY ASSOCIATES, P.A., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME
