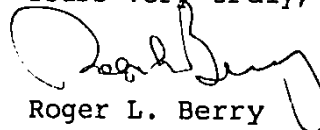

The undersigned, for the purpose of forming a corporation pursuant to the Florida General Corporation Act, Chapter 607, Florida Statutes, certifies:

ARTICLE I  
NAME

The name of this corporation is SDQ, INC.

ARTICLE II  
DURATION

The duration of the corporation shall be perpetual.

ARTICLE III  
ADDRESS PRINCIPAL OFFICE

The address of the initial principal office is 328 North Nova Road, Ormond Beach, Florida 32174, and the mailing address is the same.

ARTICLE IV  
PURPOSE

The general purpose and objective of this corporation is the operation of a fast food restaurant and the transaction of any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

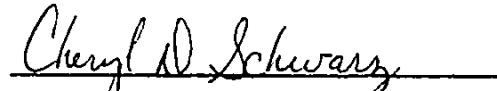

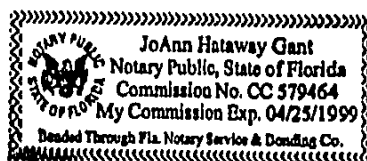

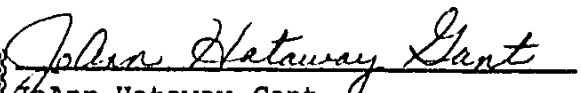
