# ARTICLES OF INCORPORATION OF

## ARTICLE 1: NAME AND ADDRESS

#### **ARTICLE 2: DURATION**

This Corporation shall exist perpetually. In accordance with Section 607.0203, the date when existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.
