ARTICLE I - NAME

The name of this professional association is JOHN J. MURPHY
III, P.A.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on
the date of execution and acknowledgement of these Articles.

ARTICLE III - PURPOSE

The corporation is organized solely for the purpose of
conducting the practice of law only through persons who are
officers, employees or agents who are duly licensed or otherwise
legally authorized to render such professional services within
the State of Florida. Such persons shall practice the profession
of law in accordance with all rules for professional conduct
promulgated by the Supreme Court of the State of Florida. The
corporation shall at all times comply with standards of
professional conduct promulgated by such Court. The corporation
is organized to engage in the practice of law; to appear in a
representative capacity as an attorney; to draw papers,
pleadings, or documents, to perform any act in connection with

the legal proceedings before a Federal, state or city court or any subdivision thereof; to advise or direct others as to civil or criminal law; enforce, settle, adjust or compromise defaults, disputes, claims; prepare, draw, assist in the preparation or drawing of any papers relating to the rights of others; and to prepare, draw, procure or assist in the preparation of drawing Affidavits, Deeds, Wills, Conveyances and Mortgages. The corporation is further organized for the purpose of transacting all other lawful business ordinarily conducted by attorneys at law throughout the State of Florida and the United States subject to the laws of the State of Florida and the Florida Code of Professional Responsibility.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of common stock having a par value of \$1.00 per share.

ARTICLE V - PREMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

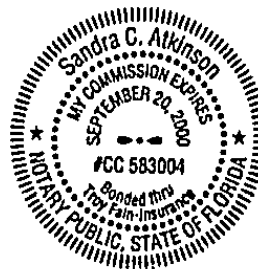


