ARTICLES OF INCORPORATION

OF

MART INTERNATIONAL TRADERS, INC.

ARTICLE 1 - NAME

The name of this corporation shall be :

MART INTERNATIONAL TRADERS, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The general nature of the business to be transacted by this corporation shall be any and all activities permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue five hundred (500) shares of common stock with a par value of one dollar (\$1.00) per share.

ARTICLE V - VOTING RIGHTS

The amount of capital with which this corporation shall begin business is not less than five hundred dollars (\$500.00).

ARTICLE XIII - MANAGEMENT OF CORPORATION "Y SHAREHOLDERS

All corporate powers shall be exercised by or un ar the authori of, and the business and affairs of this corporation shall . managed under the direction of, the shareholders of s corporation.

ARTICLE XIV - POWERS

This corporation shall have all the corporate powers enumerated in the Florida General Corporation Act.

ARTICLE XV - DIRECTORS RESIDENCY AND COMPENSATION
