ARTICLES OF INCORPORATION

OF

WAVECHASER HOLDINGS, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation, Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of this corporation is Wavechaser Holdings, Inc.

ARTICLE II. DURALION

The corporation shall exist perpetually commencing on the date of the filing of these Articles.

ARTICLE III. PRINCIPAL PLACE OF BUSINESS
