"PLAN OF COMPLETE LIQUIDATION AND DISSOLUTION OF USA WHOLESALE AGENT SERVICES, INC.

This Plan of Complete Liquidation and Dissolution is for the purpose of effecting the complete liquidation and dissolution of USA WHOLESALE AGENT SERVICES, INC., a Florida Corporation, hereinafter called the Corporation, pursuant to the following steps:

- 1. Plan of Liquidation. The Corporation has issued and outstanding <u>IOO</u> common shares, of the par value of \$ <u>IOO</u> each. The Corporation will cease the active conduct of its business effective as of September 1, 2000, wind up its affairs and, within the meaning of Section 331 of the Internal Revenue Code of 1986, as amended, will liquidate and distribute all of its assets in complete liquidation, less any assets retained to meet claims.
- 2. <u>Assets and Liabilities.</u> The principal assets of the Corporation include, but are not limited to, cash in banks, [inventory/accounts receivable], [a lease] and goodwill. The liabilities of the Corporation are minimal.

The Directors may from time to time authorize one or more distributions of property of the Corporation, in cash or in kind, in a series of distributions in complete liquidation, retaining such assets as they may deem necessary to meet claims or liabilities of the Corporation, and to continue the operation of such properties of the Corporation as have not been sold at the time of any such distribution.
- 5. <u>Cancellation of Outstanding Shares.</u> Each of the foregoing distributions in complete liquidation shall be in exchange solely for, and in complete redemption and cancellation of, and in payment of, all of the outstanding common shares of the Corporation, and the Shareholders shall, if the Directors so determine, surrender their certificates for their respective shares of the net assets of the Corporation, and shall surrender such certificates for cancellation upon receipt of the final distribution herein authorized.
- 6. <u>Dissolution</u>.
