ARTICLE I

NAME

The name of this Corporation is MILLER & BROWNLESS, P.A.

ARTICLE II

DURATION

This Corporation shall have perpetual existence.

ARTICLE III

PURPOSE

The purposes for which the Corporation is formed are as follows:

1. To engage in the general practice of law.
2. To invest its funds in real estate, mortgages, stocks, bonds, or any other type of investment and to own real or personal property necessary for the rendering of the professional services specified above.
3. To do such acts and carry on such business as may be permitted by the rules and regulations of the State of Florida, as they pertain to professional corporations and subject to the

limitations thereof.

#### ARTICLE IV

##### CAPITAL STOCK
