The undersigned incorporators to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation shall be: ABDIEL ORTIZ CONSULTANTS INC.

ARTICLE II: PRINCIPAL OFFICE ADDRESS

The principal office and mailing address of the corporation shall be located at 2121 W. Rambla St. Tampa, Florida 33612.

ARTICLE III: EXISTENCE

The corporation shall have perpetual existence.

ARTICLE IV: PURPOSE

The nature of the business and the objects and purposes proposed to be transacted, promoted or carried on are to engage in any and lawful business for which corporations may be incorporated under the Florida General Business Corporation Act.

ARTICLE V: CAPITAL STOCK

The corporation is authorized to have at any one time One Thousand (1,000) shares of common stock, having a par value of one Dollar (\$1.00) per share.

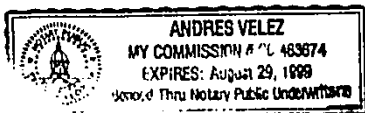
