ARTICLES OF INCORPORATION OF EQUIMAX CORPORATION:

ARTICLE I. NAME

The name of the corporation is EQUIMAX CORPORATION.

#### ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 19050 Glades Road, Port St. Lucie, FL 34987.

### ARTICLE III. DURATION
