The undersigned subscribed to these Articles of Incorporation, natural person competent to contract, to hereby form a corporation under the provisions of Chapter 607 of the laws of the State of Florida.

ARTICLE I: NAME AND PRINCIPAL ADDRESS

The name of the corporation shall be : TRANSATLANTIC CONNECTIONS, INC.  
and its principal office shall be : 5702 RIVERSIDE DRIVE  
HARBOR OAKS, FL 32127

The Board of Directors may from time to time move the principal office to an other address in Florida.

ARTICLE II: TERM AND COMMENCEMENT

The period of duration of this corporation is PERPETUAL, unless dissolved according to law. Corporate existence shall commence upon: filing these Articles of Incorporation by the Florida Department of State.

ARTICLE III: NATURE OF BUSINESS

The general nature of the business by this corporation is : To manufacture, purchase or acquire, own, mortgage, sell assign, transfer, or dispose of, and to invest in, trade, deal with goods, wares, merchandise, real, intellectual, and personal property and services, of every kind, class, and description. The corporation shall have and exercise all powers conferred on a corporation by the Florida Statutes.

#### ARTICLE VII: BOARD OF DIRECTORS


