The undersigned subscribers to these ARTICLES OF INCORPORATION, each a natural person, competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Plorids.

I.

NAME

NATURE OF BUSINESS

The general nature of this business to be transacted by this corporation is:
