ARTICLE I

Name of Corporation

DELL EDENFIELD BAIL BONDS, INC.

ARTICLE II

Business of Corporation

The corporation may engage in the business of selling insurance/bail bonds and may also engage in any other lawful activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

Capital Stock

The maximum number of shares of capital stock this corporation is authorized to have outstanding at any one time shall be two hundred (200) shares of common stock having a par value of One Dollar (\$1.00) per share. The common stock shall be entitled to one vote per share.

ARTICLE IV

Preemptive Rights

No stockholder shall have any preemptive right to purchase new stock or any type of stock of this corporation.

ARTICLE V

Corporate Existence

The existence of this corporation shall commence at 12:01 A.M. on December 1, 1996, and thereafter it shall have

perpetual existence.

#### ARTICLE VI

##### Principal Place of Business

#### ARTICLE VII

##### Resident Agent

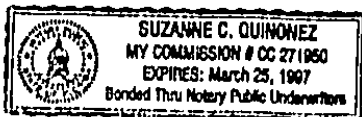
