ARTICLE I - NAME

The name of this Corporation is Stefan S. Assam D.D.S. P.A.

ARTICLE II - DURATION

This Corporation shall exist perpetually commencing on the date these Articles are filed.

This Corporation is organized for the purposes of conducting a dental practice as a Doctor of Dental Surgery.
