ARTICLE I - NAME

The name of this corporation is NATURE'S SPIRIT, INC.

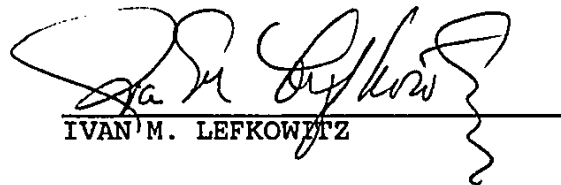
ARTICLE VIII - BY-LAWS

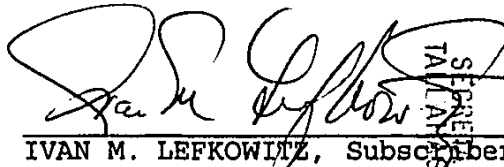

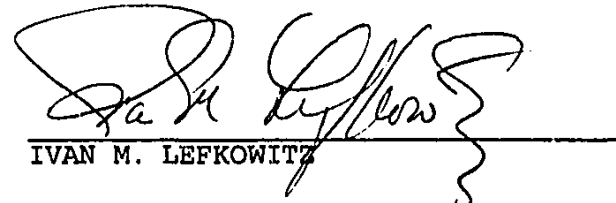
