The undersigned, being of legal age and a natural person, does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation for profit under the laws of the State of Florida.

# ARTICLE I

#### NAME

The name of the corporation is **MERIT PUBLISHING INTERNATIONAL**, **INC.** (hereinafter referred to as the "Corporation"). The principal office and mailing address of the Corporation is 8260 N. W. 49th Manor, Coral Springs, Florida 33067.

#### ARTICLE II

#### **PURPOSE**

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the General Corporation Act of the State of Florida.

#### **ARTICLE III**

#### TERM
