# ARTICLES OF INCORPORATION OF J. JEROME MILLER, P.A.



# ARTICLE I

## NAME

The name of this Corporation is J. JEROME MILLER, P.A.

## ARTICLE II

#### DURATION

This Corporation shall have perpetual existence.

## ARTICLE III

# PURPOSE

The purposes for which the Corporation is formed are as follows:
