ARTICLES OF INCORPORATION OF J. JEROME MILLER, P.A.

ARTICLE I

NAME

The name of this Corporation is J. JEROME MILLER, P.A.

ARTICLE II

DURATION

This Corporation shall have perpetual existence.

ARTICLE III

PURPOSE

The purposes for which the Corporation is formed are as follows:
