**ARTICLE I - NAME**

The name of this Corporation is HYPE MODELS, INC. and its address is 6423 Collins Avenue, Suite 905, Miami Beach, FL 33140.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence commencing on December 2, 1996.

**ARTICLE III - PURPOSE**

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE IV - CAPITAL STOCK**

This Corporation is authorized to issue 1,000 shares of one (\$1.00) dollar par value common stock, which shall be designated "Common Shares."

#### ARTICLE VIII - PREEMPTIVE RIGHTS

Every Shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.


