## CERTIFICATE AND ARTICLES OF INCORPORATION

## OF

## BAY DESIGN GROUP, INC.

CHALLA PHE 06 The undersigned person, having the age of eighteen (18) years or more, has associated him for the purpose of forming a corporation under the laws of the State of Florida and does hereby adopt the following Certificate and Articles of Incorporation.

- 1. Name. The name of this corporation is Bay Design Group, Inc.
- Purpose and Powers. This corporation is organized for the transaction of any and all lawful 2. business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time, and specifically but not limited thereof, the purpose of: Engineering design.

This corporation shall have the broad general powers set forth by regulation and statute in this state.
