To Whom It May Concern,

On October 27th, we received a Certificate of Administrative Dissolution or Revocation for Bay Design Group, Inc. We were shocked and confused as to how this could have happened. We called immediately and were told that two prior notices in green envelopes were sent warning us of the dissolution. Both my husband (President of the corporation) and I discussed the situation and neither of us ever received the two prior notices. If we had, we would have acted immediately. We always pay our bills.

Bay Design Group, Inc. is a ma and pa business out of our home. We just got started this year and hired an accountant and a payroll company to keep us current on all our fee obligations and we thought we had everything taken care of. We were incorporated in November of 1996 and were not aware that any fees were due before a year was up. So, without the receipt of the two prior notice, we would never have thought to send an annual report fee any sooner.

I called your office again and spoke to Stacy to find out what we could do about the situation and she told us to write a letter explaining our circumstances, fill out the application for reinstatement and to send a check for \$165.00. It is our hope that your office will accept the annual report fee and reinstate our corporation. Dissolution or Revocation of our corporation would work a great financial hardship on our business. There are a lot of rules to running a corporation and we thought that we could rely on the professional people that we hired to tell us what to do. The important Facts Sheet clearly spelled out when the annual report fee is due and we are sorry that we were confused about filing in a timely manner. It will not happen again.

Enclosed please find the check and the Application for reinstatement. We eagerly await your response.
