# Articles of Incorporation of David Tyson Cleaning, Inc.

The undersigned subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form a corporation under the laws of the State of Florida.

#### **ARTICLE ONE**

The name of the Corporation is David Tyson Cleaning, Inc.

### **ARTICLE TWO**

The corporation is organized for the purpose of engaging in any activities as they relate to cleaning businesses permitted under the laws of the United States and the State of Florida.

#### **ARTICLE THREE**

This corporation shall exist perpetually unless dissolved according to Florida law.

# **ARTICLE FOUR**

The corporation is authorized to issue ten thousand (10,000) shares of one dollar (\$1.00) par value common stock, which shall be designated "Common Shares."

#### **ARTICLE FIVE**
