First

The name of the Corporation is: PROSPERITY UNISEX SALON, INC.

Second

The period of duration of the Corporation is to be perpetual.

Third

The purpose or purposes for which the Corporation is organized is to engage in and conduct any and all business activities permitted under the laws of the United States and of the State of Florida.

Fourth

The aggregate number of shares which the Corporation is authorized to issue is: 500 (FIVE HUNDRED). Such shares shall be of Common Stock having a par value of ONE AND NO/100 (\$1.00) DOLLAR per share.
