Indemnification

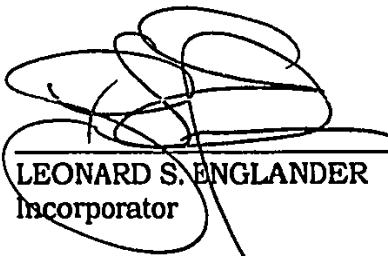
