- (3) The dissolution was approved by the unanimous written consent of William M. Vanderpool, Jr., sole Shareholder, and the Directors of the Corporation.

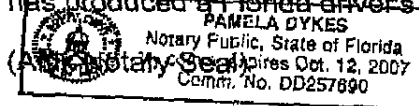
