ARTICLES OF INCORPORATION OF BARGAIN DOLLAR, INC.

THESE ARTICLES OF INCORPORATION are hereby adopted by the difference incorporator(s) of this corporation for pecuniary profit under the Florida Business PLORIDA Corporation Act.

ARTICLE I. NAME AND LOCATION OF AGENT AND OFFICES

SECTION 1.1 NAME:

The name of the corporation shall be BARGAIN DOLLAR, INC. SECTION 1.2 PRINCIPAL OFFICE or MAILING ADDRESS:

SECTION 4.2 CONSIDERATION:
