ARTICLES OF INCORPORATION

OF

NATIVE TREE AND LAWN EXPERTS, INC.

The undersigned, for the purpose of forming a corporation for profit under the Florida General Corporation Act, do hereby adopt the following articles of incorporation.

ARTICLE I

NATIVE TREE AND LAWN EXPERTS, INC.

The name of the corporation shall be: NATIVE TREE AND LAWN EXPERTS, INC.

ARTICLE II

DURATION

The corporation shall have perpetual existence with an effective commencement date of January 1, 1997.

ARTICLE III

PURPOSE

The general purposes for which the corporation is organized are:

1. To engage in the business of tree and lawn services.
2. To transact any other lawful business activity for which corporations may be incorporated under the Florida General Corporation Act.






